## New BOD Candidate



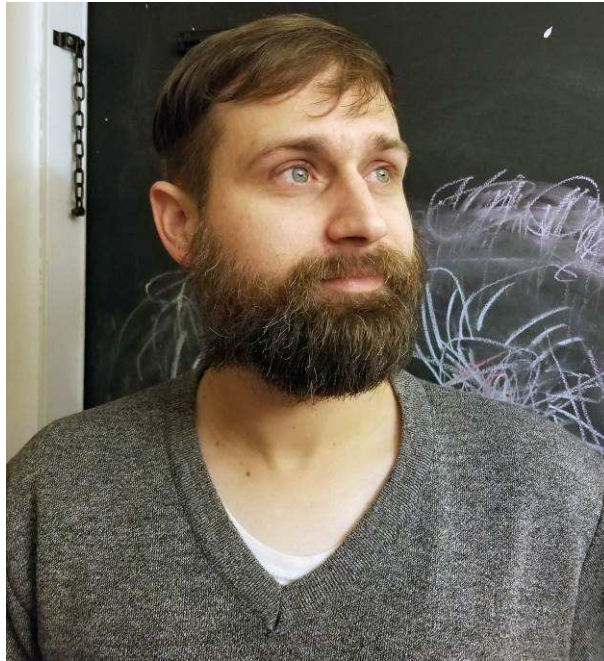

Current Director



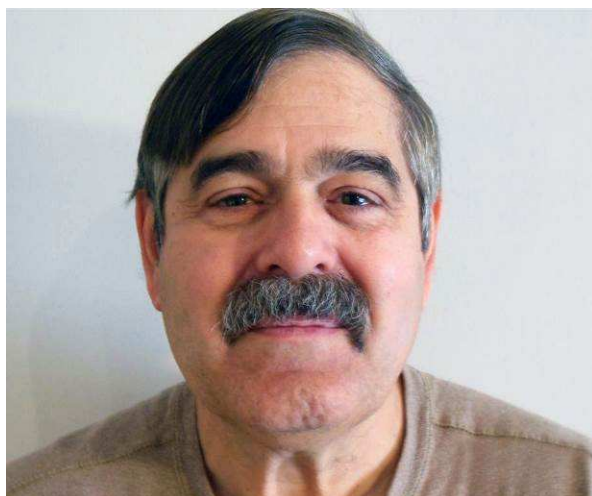

**Current Director – Club Treasurer**



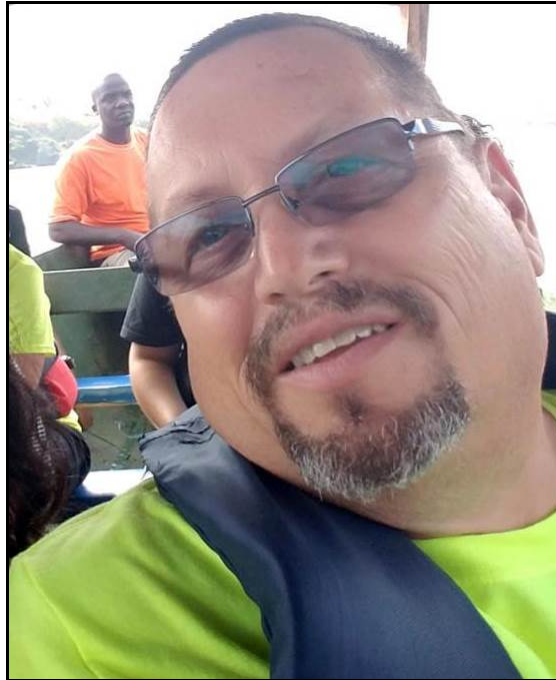

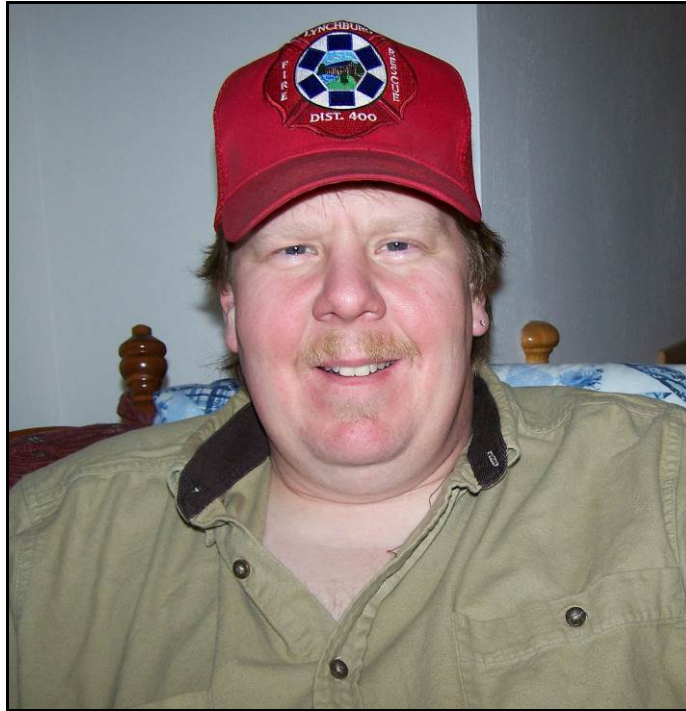

## **CCFSA LEGISLATIVE, DECEMBER 2019**

- Trump talks mental health legislation ... President Trump reportedly abandoned any notion of gun control. According to reports over the weekend. Instead, he's turned his focus to mental health legislation. That's a shift after tragic murders in El Paso and Dayton, Ohio, when President Trump said he would seek bipartisan "strong background checks," later adding the Fix NICS Act was passed and proposals for universal background checks wouldn't have prevented these crimes.

### **From the "Can't make this stuff up Department"...**

- The New Jersey Governor recently issued an Executive Order to ban all advertising and access to insurance for concealed carriers. His thinking is it enables people to get out of the repercussions of shooting someone so more people will be shot.
- Gun owners in Pittsburgh are feeling a little better this week after a judge agreed with them that city officials had NO RIGHT to enact a gun ban. The judge struck down what has been called the city's most draconian gun law. The city enacted the ridiculous gun ban following the mass shooting at the Tree of Life temple. City officials passed the ban in a knee-jerk reaction like we've seen multiple times in recent history.

There's a lot going on now and we need to be aware of what's going on around us. It's what we train for, "situational awareness." America is depending on us.

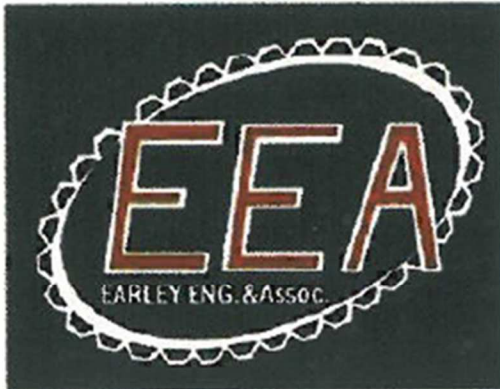
