Growing Membership

We are all in this together to make the CCFSA the premier sporting club in southern Ohio. Having reviewed many articles, I admit to having swiped several points which we should consider. In an effort to increase membership and add potential hands to help at our VOLUNTEER Club while creating a welcoming, inclusive and comfortable feel to our property, I propose we reflect on the following three areas:

Presentation

The use of new professional brochures is the first step taken to improve the most important part of the recruiting campaign presentation and first impression. By offering the "You're Invited" pamphlets/emails/facebook posts, etc, along with details of several upcoming CCFSA events such as the IDPA, Shotgun Sports, CCW Classes, creates a sense of an exclusivity and welcoming atmosphere. This was a far different approach compared to simply asking the prospect to join, a sort of "one and done" exercise that had been done in the past.

Patience

Including the prospective candidate in the summer and early fall activities provided first-hand fun and fellowship, and the ability to witness the CCFSA in action. This ongoing exposure to the club is coupled with an intentional position of patience in waiting for a response to join the membership. This lack of any "arm bending" allowed the prospect to make his own decision, and in due time. As a result, we have seen a higher percentage of new members attending meetings and choosing to become involved in Valley programs. Our more patient approach in allowing for a genuine "Yes" response has proved to be an improved recruiting method.

Persistence

Legislative Report

The following house bills have been introduced in the Ohio House of Representatives, some good, some not so good.

HB 12 - ENFORCE CONSTITUTIONAL RIGHTS REPUBLICAN SPONSORED. Rep. Diane V. Grendell: To provide for a writ of mandamus or prohibition to enforce a person's constitutional right against a chief administrative officer or elected executive official whose duty is to uphold the Ohio and United States Constitutions. [This makes any Ohio representative/senator unable to enter a bill that is contrary to the Second Amendment to the Bill of Rights or the Constitution]

HB 38 - REQUIRE DUTY TO RETREAT DEMOCRATIC SPONSORED. Reps Thomas West, Adam C. Miller: To repeal Senate Bill 175, passed last session, and bring back the duty to retreat in Ohio. [This places Ohio citizens back in jeopardy to PROVE they had no viable way to retreat placing the burden back on the victim to prove they're innocent]

HB 62 - DESIGNATE OHIO A SECOND AMENDMENT SANCTUARY REPUBLICAN SPONSORED. Reps. Mike Loychik, Diane V. Grendell) To designate the State of Ohio as a Second Amendment Sanctuary State and to name this act the Ohio Second Amendment Safe Haven Act. [This a bill that would protect the citizens of miscellaneous communities, townships, cities and counties throughout Ohio from making laws that supersede those of the state]

HB 89 - REPEAL THE DUTY TO "PROMPTLY" INFORM REPUBLICAN SPONSORED. Sponsor: Scott Wiggam) To modify the requirement that a concealed handgun licensee must notify a law enforcement officer that the licensee is authorized to carry a concealed handgun and is carrying a concealed handgun when stopped. [I read the text of this proposed bill and for me it's difficult to grasp. To be on the safe side, if stopped by law enforcement I will continue to keep my hands on the wheel and advise the officer asap that I have a CCW and am armed. I'll update as necessary]

Today, 3-3-2021, the House State and Local Government Committee is hearing House Bill 89 to amend Ohio's "duty to inform" law. **Please contact committee members and ask them to SUPPORT HB 89.**

HB 99 - EXEMPT ARMED SCHOOL PERSONNEL FROM POLICE TRAINING REPUBLICAN SPONSORED. Sponsor: Thomas Hall) To expressly exempt persons authorized to go armed within a school safety zone from a requirement to complete extensive peace officer basic training. [amend

sections 109.78 and 2923.122 of the Revised Code to expressly exempt persons authorized to go armed within a school safety zone from a requirement that peace officer basic training be obtained and to require that those persons successfully complete firearms training that meets or exceeds the training requirements for concealed handgun licensees for the exemption to apply]

Below The Radar at the Federal Level – HR 1004, Sponsored by Carolyn Maloney (D-NY) Requires Liability Insurance Coverage to Purchase Firearms, provided Courtesy of AmmoLand:

The text of the legislation as introduced in the 115th Congress states that it is unlawful to buy a firearm without a “qualified liability insurance policy” and that it is also illegal to sell to someone without said “qualified liability insurance policy.” Now, the definition the text provides is vague, beyond saying that the policy should provide “liability insurance covering the purchaser specifically for losses resulting from use of the firearm while it is owned by the purchaser.”

In my opinion, this would be completely unenforceable without a mandated national registration program. With the millions of guns in circulation, it does little more than having a Reps name on something which will accomplish nothing, further hamper the Legal Commerce in Firearms Act, while hexing gun ownership and picking away at the 2nd Amendment.

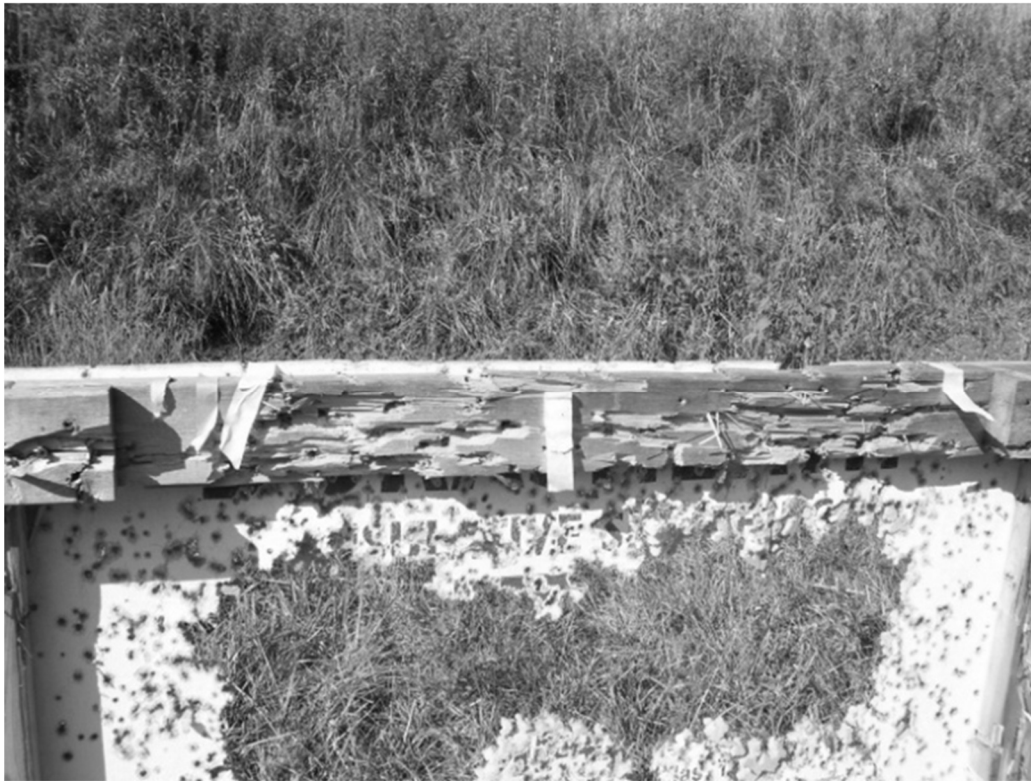

Range Restrictions



Do not shoot at the target supports

Do not shoot target frames

Do not shoot insulation board with shotguns

Violators will be charged for repair of the target stands

Attach paper targets with staples or by other non destructive means such as tape.

Use snow fence target stands or your own targets for shotgun use.

Range Cleanup



Do not leave any trash except in the supplied garbage containers.

No live ammunition including rim fire, will be left on the range, please place in the proper containers but not the trash cans.

Remember we have houses with curious kids near by.

Place any live ammo found on the range in the DUD ammo box.

Please pickup your trash and put into cans

Although the February chapter meeting was canceled due to the snow, our members have stayed active both with learning and in obtaining new certifications. Since last year, we have welcomed 11 new members and interest continues to spread. In January, Dr. Bill Kennedy and his son Jason of Team Torque in Wilmington, taught our members about personal self-defense basics at our chapter meeting. Shotgun Sports Rate Change

Due to the increasing expenses for targets and equipment maintenance, the Shotgun Sports pricing will be updated, effective April 1, 2021. We have done everything we can to keep the pricing as fair as possible, especially for our members. CCFSA shotgun sports are all operated and maintained by volunteers, and all income goes back into our club.

The club rate for Skeet & Trap (25 targets per round) will remain \$4/round for CCFSA members and will increase to \$6/round for non-members.

The club rate for Five Stand (25 targets per round) will be \$5/round for CCFSA members and will be \$7/round for non-members. The higher price for Five Stand is due to the additional throwing machines, target types, and other equipment required.

The Shotgun Committee will continue to monitor the operating costs and update pricing as necessary. We are hopeful that this will keep the shotgun sports at CCFSA sustainable for long into the future.

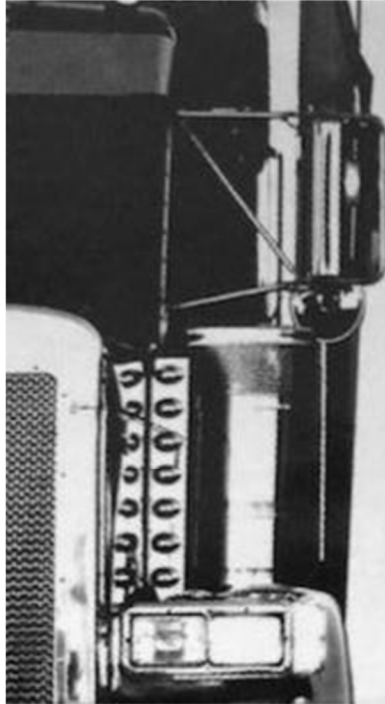
