Dave says: The firearms industry is under attack by nearly every state in the country.

Gov. Mike Dewine did one thing right by designating firearms manufacturers, warehouses, distributors and dealers as *ESSENTIAL SERVICES* allowing them to serve customers who need to protect themselves and their families during these uncertain times. There were 1.7 million firearms flew off the shelves in May, setting an all time record, many to first time gun owners. While less favorable things he is considering like Red Flag Laws among others is concerning, we have time to see where he really stands, if he is a true 2nd Amendment supporter. Stay tuned...

Update: Florida Governor's Order Supersedes All Local Orders – Firearm Industry Can Remain Open Throughout Florida

Gov. Ron DeSantis' [Executive Order No. 20-91](#), which requires the closure of businesses and services not designated "essential." Gov. DeSantis issued a [follow-up order](#) stating Executive Order No. 20-91 "shall supersede any conflicting official action or order issued by local officials in response to COVID-19."

Gov. DeSantis' Executive Order No. 20-91 contains an explicit reference to all services detailed in the Department of Homeland Security's CISA [guidance](#) on essential workers. The guidance (as of March 28) includes "workers supporting the operation of firearm or ammunition product manufacturers, retailers, importers, distributors, and shooting ranges." This means all firearm and ammunition product manufacturers, retailers, distributors, importers and shooting ranges in Florida may remain open for business.

Indiana AG Hill Affirms Local Governments May Not Regulate Firearm Industry

Over the past week, the National Shooting Sports Foundation[®] received various reports of local political subdivisions in Indiana overstepping their legal authority and ordering firearm retailers to temporarily close.

Following the quick efforts of the NSSF[®], Indiana Attorney General Curtis Hill issued a clarifying opinion, [stating](#) that firearm and ammunition-related businesses can remain open.

Attorney General Hill concluded his opinion:

"No unit of government in the State of Indiana has the power to restrict the lawful exercise of the right to bear arms during a state or local emergency. Furthermore, local units are prohibited by Ind. Code § 35-47-11.1-2 and Ind. Code § 10-4-3-33.5 from ordering firearm retailers to close their businesses or in any other way restricting or prohibiting the transfer or sales of firearms during an emergency declaration or otherwise."

Meanwhile in New York: Gun Permit Processing Suspended, Remington Shut Down, but Offers Emergency Services

They've called us "crazy alarmists" and "conspiracy theorists" every time Second Amendment supporters have mentioned their concern that one day, the government could simply revoke our Constitutional right to keep and bear arms. In New York, the right is not revoked, but it is suspended, until further notice. With the all-too-easy excuse of COVID-19 containment, 52 of New York State's 62 counties have suspended pistol permit processing, either officially, or by simply letting it fall by the wayside. What's more, the state also declared the Remington Arms plant in Illion, NY, employing more than 800 people, a "non-essential" business and forced its closure. This follows a massive, nation-wide gun buying explosion, as the heritage gun-manufacturer is required to cease production. To keep their employees on payroll, Remington has offered up its 1-million square foot factory to be utilized for medical equipment manufacturing. Several antigun U.S. Senators wrote to the FBI and ATF to suspend sales and break the law rather than provide resources as NSSF strongly recommends.

Interior Sec. David Bernhardt is proposing to open 2.3 million acres for hunting and fishing across 97 National Wildlife Refuges and nine national fish hatcheries, the largest expansion in history.

Virginia Gov. Ralph Northam announced that he signed numerous antigun bills into law, and sent two back with amendments. In a sad turn of events, U.S. District Court Judge William Young has issued a ruling that upholds Massachusetts' ban on AR-15s and large-capacity magazines. His reasoning? He says AR-15s are NOT protected by the 2nd Amendment.

He wrote: "The AR-15 and its analogs, along with large capacity magazines, are simply not weapons within the original meaning of the individual constitutional right to 'bear arms'."

NINTH CIRCUIT SALVAGES CALIFORNIA AMMO BACKGROUND CHECKS ... The U.S. Court of Appeals for the Ninth Circuit issued an emergency administrative stay Friday halting a preliminary injunction against California's Prop 63 ammunition background check laws. For now, ammunition purchases are again subject to a face-to-face sale by a licensed vendor and a background

check, and internet drop-shipment sales direct to consumers are not permitted until an appeal can be heard.

NSSF recognized U.S. Sen. Shelley Moore Capito (R-W. Va.) as the 2019 **Legislator of the Year** for her commitment to Second Amendment rights and leadership in passing the Target Practice and Marksmanship Training Support Act into law.

NSSF offered **strong support** to the Army Corps of Engineers' proposal to allow firearms on Corps-managed lands and waters.

Washington, D.C.'s Metro Police Department is now the **sole** federal firearms licensee in the city. NSSF's Larry Keane noted it's not ideal but allows for firearm transfers to continue.

The sales happened in spite of a significant number of gun shops being shut down by decree by state governors, then re-opened after protests, **lawsuits**, and the Trump administration **declaring them essential businesses**.

CALIFORNIA: Bills being introduced to the legislature.

AB 2847, sponsored by Assembly Member David Chiu (D-17), revises the criteria for handguns to be certified for sale in California by requiring the microstamp to be imprinted in one place on the interior of the handgun (currently requires two imprinting locations) in addition to the other current requirements. It would further require the department to remove three certified handguns from the list for each new handgun added.

AB 2362, sponsored by Assembly Member Al Muratsuchi (D-66), authorizes the Department of Justice to levy monetary fines on licensed firearms dealers, in addition to the existing enforcement mechanisms which includes, up to the revocation of a dealer's license. This increased authority to levy fines up to \$1,000 for minor violations is ripe for abuse and could ultimately drive dealers out of business for inconsequential violations.

MORE ELSEWHERE:

Maryland's Gov. Larry Hogan **vetoed** two antigun bills NSSF opposed that would have required private sales or permanent transfers of long guns to be facilitated by an FFL.

Pittsburgh attorneys **appealed** a judge's order striking down three gun control ordinances passed in 2018. Pittsburgh attempted and **lost** a similar gun control scheme at the state Supreme Court in 1993.

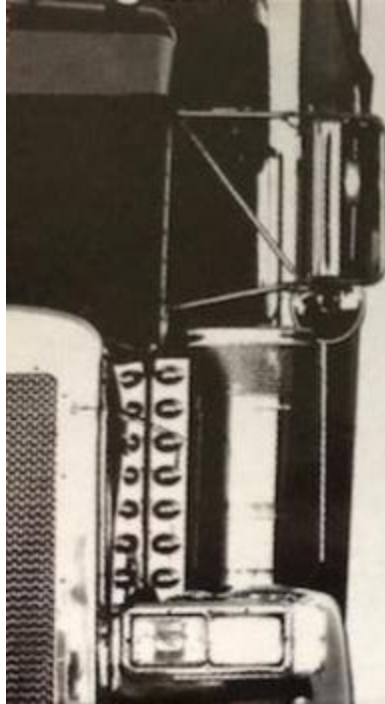

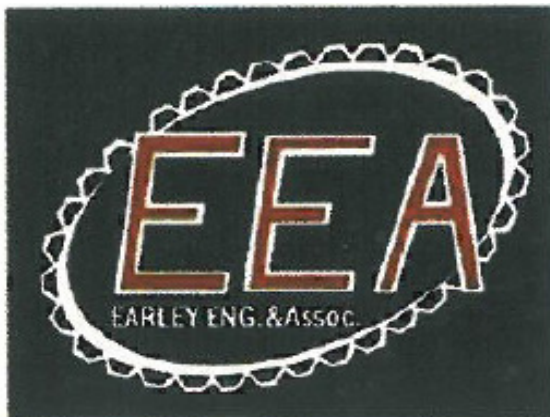

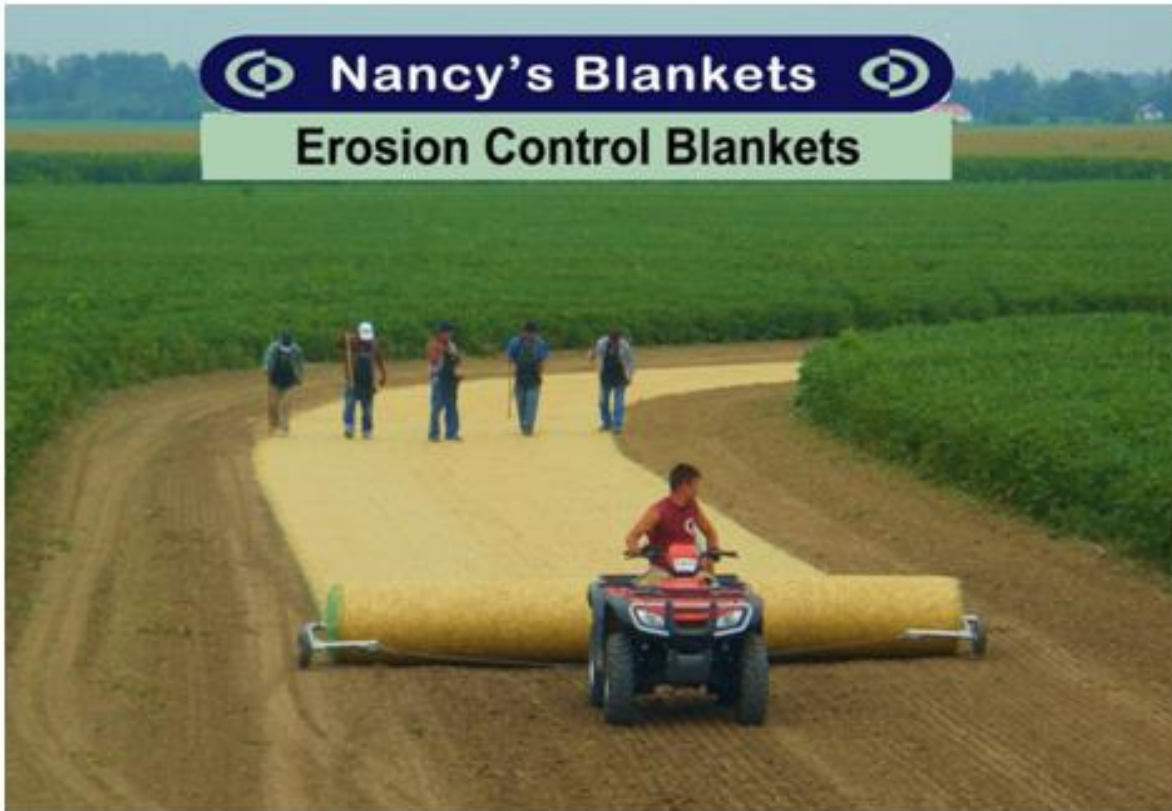
