CCFSA LEGISLATIVE REPORT 12-08-2021

On December 2, U.S. Senator Chris Murphy (D-CT) attempted and failed to pass H.R. 8, the dangerously flawed, so-called "universal" background check bill. *Senator Grassley, (R-IA) shut the door to this Democratic plan to create a back door national database of firearm ownership.*

The Ohio State House of Representatives just passed constitutional carry (House Bill 227) legislation by a vote of 60-32. The legislation now heads over to the Ohio State Senate for consideration. House Bill 227 will join another constitutional carry bill, Senate Bill 215, in the upper chamber.

Nancy Pelosi has just turned up the heat on H.R. 3088, legislation that makes felons out of Americans who possess home-made firearms that the feds know nothing about! Known as 80% lowers, these home-made build kits are wildly popular with gun owners who enjoy using them to make anything from an AR-15 to a Ruger 10/22 using their own tools. In fact, H.R. 3088 has over 100 cosponsors and was JUST REFERRED to the House Judiciary's Sub-committee on Crime, Terrorism, and Homeland Security where it is expected to have a hearing very shortly. The intention of this legislation is crystal clear. And it has nothing to do with stopping violent crime. So please take action against this legislation right away.

America is the freest country on earth because it's the most well-armed country on earth. But if we ever lose our ability to defend ourselves against tyranny, those freedoms will evaporate!

A federal assault weapons ban has been introduced in both the United States House and Senate. As most of you know, congressional authoritarians successfully passed an AWB in the early '90s. Fortunately, that ban was not continued. However, we know the desire is there to try it again. So far this renewed attempt has well over 200 co-sponsors in the U.S. House of Representatives. In fact, 37 U.S. Senators have already signed on to support this latest effort as well. In such a closely divided legislature, every vote will count. **That's why we are asking you to reach out to your specific legislators to exert some grassroots political pressure against this reimagined attempt to erode our rights.**

H.R. 1808/S. 736, also referred to as the Assault Weapons Ban of 2021, arbitrarily labels many rifles, shotguns, and other firearms in common use as "assault weapons." Of course, the term "assault weapon" is a made-up label created by anti-gun activists to slander modern firearms. These lengthy bills go on to provide an extensive list of firearms that anti-gun special interest groups and legislators would like to see banned.

2021 Already Second Strongest Gun Sale Year on Record

November 2021's NSSF-Adjusted National Instant Criminal Background Check System (NICS) total of 1,543,378 brings the year-to-date total to 16,722,291 background checks for the sale of a firearm. That makes 2021 the second strongest year on record, behind only 2020's outlier of a year that saw 21 million background checks for a

gun sale. "This milestone figure of more than 16.7 million background checks for a gun sale shows there is still a strong appetite for lawful firearm ownership and America values the God-given right to keep and bear arms," said NSSF's Mark Oliva to [media](#).

"Month after month, and now year after year, Americans are voting with their wallets when it comes gun rights in record numbers.

According to Rand Paul, Armed agents in Texas have been dispatched to the homes of private citizens to arrest parents who have the "wrong opinions" about Critical Race Theory.

According to independent journalist Christopher Rufo, *"A minister and a veteran voiced opposition to the school board. The school district's police department, in coordination with the sheriff, sent armed agents to arrest them in their homes."*

This comes directly on the heels of AG Merrick Garland announcing that he would work with "local law enforcement" to crack down on parents who don't share his Left-wing views.

He even said he was going to send FBI federal agents to crack down on these parents. I have to ask..... Is this still America?

Safety committee:

First, I would like to mention we have had a decent year as far as safety concerns at CCFSA. I do appreciate the effort of the membership. I would like to mention a few items that will benefit all of us at CCFSA.

We still need to police all the ranges for live ammo. We do have live round deposit boxes on all the ranges, please do not throw live ammo in the trash cans.

In my opinion the ranges have never looked better, but we do need to stay on top of range clean up.

On rifle pistol range, it is paper targets or stationary polymer targets only. Water bottles are not polymer targets.

Target stands are to be kept as close to the backstop berms as possible.

Be safe and enjoy your time on the range.

We are also looking to increase the numbers of RSO and we do offer the class at CCFSA. If you are interested, please see the flyer in the newsletter. We would like to have least five to make a class and at that point we will start looking at dates.

Safety is every member's responsibility, whether you are on a range or using the facility for other recreational interests. The rules are put in place for everyone to follow and for everyone to enforce. Safety should be the first thing on everyone's mind. If you have a safety related issue that is on your mind, contact any director, match director, Range Safety Officer, or Safety Officer. Most of the time, especially weekends, you can find someone to fill this bill on-site. If you cannot find one on-site, give someone a call. I would like to mention that the following article is a reprint from a previous newsletter, I do feel it does fit the season where it is very easy, with the excitement of the holiday season to let our guard down.

Safe Storage of Weapons at Home

I have an agreement with my son, if I leave my handgun laying around and he finds it, I owe him five dollars. So far, I have never had to pay him that five dollars, though one time I did have to pay him one dollar for leaving out my folding tactical knife. My son now likes to tell people I will have to pay him 10 dollars if he finds my gun in an unsafe location. Hmmmm.

As American Citizens and protectors of life and freedom we invest heavily in purchasing equipment and learning procedures for the safe handling of weapons. Equally important are procedures for the safe storage of weapons. The big concern here is children, and also those who are impaired. It is not enough to only look out for risks by those who live in our household, but we must also look out for the safety of those who may visit our household.

Do you have kids? Do they have friends who come over, with or without their parents? With respect to your firearms, ask yourself the question, "what could go wrong here". That is a great way to foresee a potential problem and deliver a solution before it happens. If we don't store our firearms safely, we are not being good protectors.

The first general rule for temporary firearm storage is place it up high on the fireplace mantle or top shelf in a closet. This keeps the gun out of easy reach of a child. If away from your home, be sure to leave your car keys with your gun, so you don't drive off without it. The second general rule is the gun must be no higher than condition two, with an empty chamber. Before negligence could happen, the child would have to chamber a round.

Next, I train my kids what to do if they come across a firearm: do not touch, keep smaller kids away, go tell an adult. As soon as they are old enough, I will teach them how to clear a weapon then put it up high without pointing it at themselves or someone else.

I like to show-off how my kids are trained. In front of some shooters the other day, I asked my son, "What happens if you find my gun laying around in an unsafe place?" He answered without blinking, "You owe me twenty dollars". Good point! Safety is worth the high price.

New Range Safety Officer (RSO) 8- HOUR NRA-STANDARD RANGE SAFETY OFFICER

Thank you for your membership in CCFSA. If you would like to contribute to our club in the realm of safety, we have a training opportunity for you. We will be offering NRA certified, Range Safety Officer (RSO) training throughout the year. Charge for the course is \$65, which will include NRA books, lunch and dinner for this long day. (In other locations this course costs from \$85 to \$130).

Once certified, you do not have to serve as an RSO at a shooting event or course. CCFSA would like to have up to 200 RSO's to serve as the safety eyes and ears of the club. If you only observe and report to the safety committee, you are providing a valuable service for our members in helping to keep the club safe and professional.

PREREQUISITES: None

COST: CCSFA members \$65 Non-Members \$100

EQUIPMENT: NO AMMO IN CLASSROOM. No ammo needed for the course. Bring any unusual firearms you have for review of action. Bring CCFSA RSO Handbook(<http://ccfsa.com/documents.html>). Also eyes and ear protection plus weather specific gear.

Your entry code is derived from your Member ID number prefixed by a digit based off of your last name to create a 5 digit code.

The prefix number will be the following:

If your last name begins with A – F: your digit will be a 2

If your last name begins with G – M: your digit will be a 4

If your last name begins with N - Z: your digit will be a 5

For an example of a code: If your last name is Roberts, and your member ID is 5678.
Your code will be 55678.

If your member ID is 3 or less digits in length, prefix the digit to form a 5 digit number.
Example: Your last name is Roberts and your member ID is 49.
Your code will be 55549.

Safety

Placement of target stands

- Target stands are to be placed as close to the base of the mounds as possible.
- The firing line can move toward the back stop mounds, but you cannot bring the targets away from the mounds
- Do not shoot over the mounds.
- Do not place targets on the mounds.

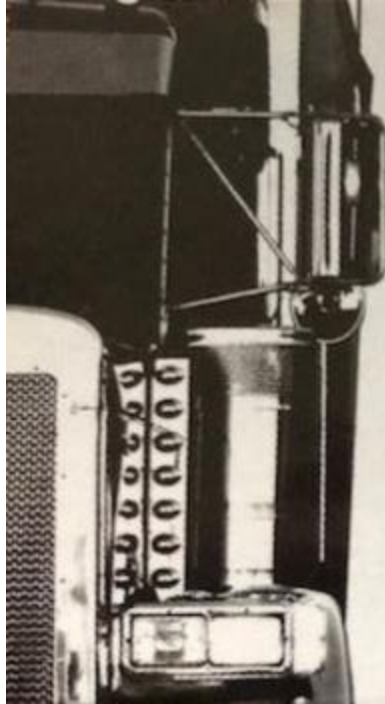

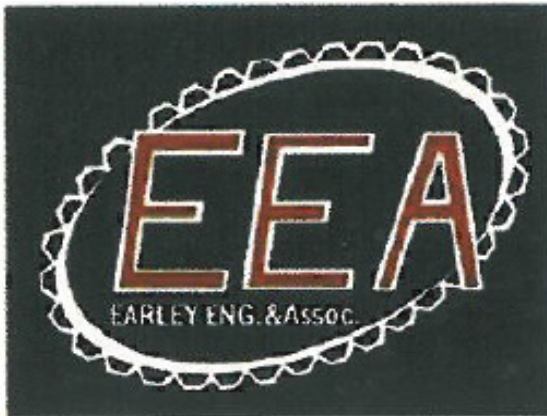

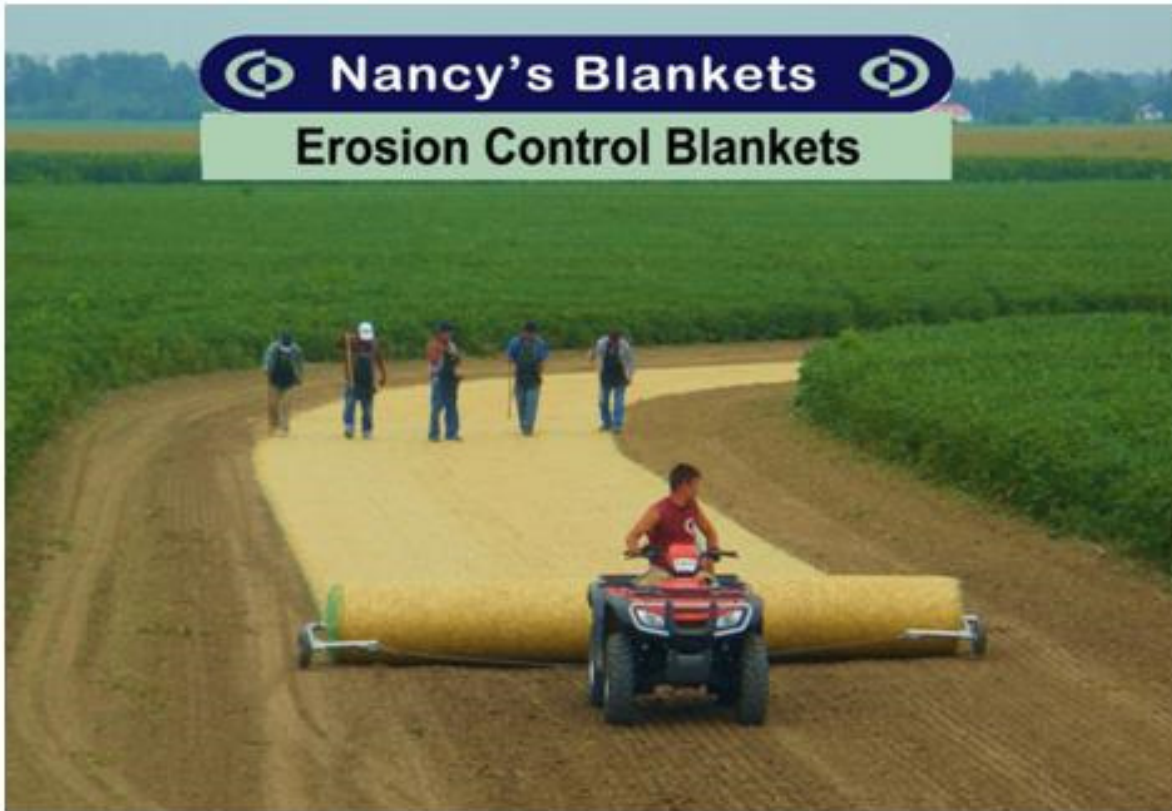
